Privacy Policy (art. 12 - GDPR)

Under the Chapter III of the European Regulation n°679/2016, and subsequent amendments and additions (hereafter, "Privacy Regulation"), on behalf of interested party, we here by inform you that the personal information either supplied or acquired in a lawful manner in the performance of our activities (hereafter "Data") are processed with respect to Privacy Regulation as well as the confidentiality responsibilities that guide the activities of **CANTIERE DEL PARDO S.P.A.**

The data are collected either by the interested party either by other sources (eg. files, relatives, etc.). The Data can be collected through telematic methodologies and they can be successively processed by computerized and manual means.

The processing is carried out in conformity with current security norms and practices, with particular reference to the full text of the Privacy Regulation. Information system and computer programs are designed to minimise the use of personal and identifying information that is unnecessary to the below-listed processing.

Data are processed by CANTIERE DEL PARDO S.P.A. for the following purposes:

1. **To send newsletters/brochures/catalogues;**
2. **Invitation to future promotional events;**
3. **To communicate data of potential clients to dealers and to receive data from dealers.**

The provision of personal data is necessary for the performance of the activities related to the purposes above mentioned, therefore, in case of your refusal to provide personal data, it will not be possible to proceed to the specific treatment.

For the proper discharge of these purposes, only the Data Controller, the Data Processor, the DPO and those authorized to process the data can access to the collected data. The complete and updates list of delegates will be made available to you by the Data Controller.

The data collected and processed for the above-listed purposes will be communicated to the following target groups.

- **Software House;**
- **Revenue Agency;**
- **Italian/ foreign dealers.**

The criteria which determine the period for which records should be kept are related to mandatory administrative requirements with a minimum period of 10 years from the acquisition of the single data.

We inform you that you can assert the rights according to chapter II and III of the European Regulation, n° 679/2016, among which we remind you the right to withdraw your consent at any time (art. 7 chapter II), the right to obtain from Data Controller the confirmation that the processing of personal data has been made and the right to complain to a supervisory authority (Art. 15 chapter III), the rights to obtain from the owner the correction of your inaccurate personal data (art. 16 chapter III), the right to obtain from the Data Controller the cancellation of your personal data (Art. 17 chapter III), the rights to obtain from the owner the limitation of the processing (Art. 18 chapter III), the right to receive data in a structured format in order to transmit them to any other Data Controller without any impediment (art. 20 chapter III), the right to object at any time, for reasons connected with a particular situation, to a processing of a personal data (art. 21 chapter III).
